

Terms and Conditions

#MyGinninderry Photography Competition

These Terms and Conditions relate to the #MyGinninderry Photography Competition ("Competition"), which is being conducted by Riverview Projects (ACT) Pty Limited ACN 165 870 539 ("Riverview Projects").

Key Terms

Information on how to enter and prizes form part of these Terms and Conditions. By participating, Eligible Entrants (as defined below) agree to be bound by these Terms and Conditions. Entries must comply with these Terms and Conditions to be valid. To the extent of any inconsistency between these Terms and Conditions and any other reference to the Competition in any marketing or other materials, these Terms and Conditions prevail.

Eligible Entrants

Entry is open to residents of Australia aged 18 years and over who are a member of or are following the 'Strathnairn Locals' Facebook page or a resident of the suburb of Strathnairn in the Australian Capital Territory ("Eligible Entrant"). Riverview Projects employees, and their immediate families, its related entities and any agencies associated with the Competition are ineligible to enter.

How to Enter

During the Competition Period (as defined below), Eligible Entrants must upload their photo to the 'Ginninderry Locals' Facebook Page and/or their personal Facebook or Instagram page with the hashtag #MyGinninderry.

If uploading their photo to a private Facebook or Instagram page, submissions must be uploaded to the Ginninderry Locals' Facebook Page or emailed to community@ginninderry.com to be determined eligible. These submissions may then be posted to Ginninderry Locals' Facebook Page and/or the Ginninderry website on their behalf.

If uploading photos by Facebook, please also email the full resolution files to community@ginninderry.com to ensure Riverview Projects has a high resolution (printable) photo available for display, if required.

Entry into the Competition is free.

Limits on Entry

An Eligible Entrant can publish more than one submission. However, an Eligible Entrant is only eligible for one of the first, second or third prizes. All entries are eligible to receive the People's Choice Award in conjunction with a first, second or third prize.

The Competition commences at 12:00 PM AEDT on Wednesday 21 June 2023 and closes at 17:00 PM AEDT on Wednesday 12 July 2023 ("Competition Period"). Entries received outside the Competition Period will not be accepted.

Judging Dates

Judging will take place by a panel of judges from Riverview Projects at 14:00 PM AEDT on Thursday 20 July 2023. All entries will be judged individually on their merits based on creativity and originality in accordance with the following criteria.

Capturing the moment (5 points) Creativity (5 points) Ginninderry-Inspired (5 points) Photographic skill (use of light; composition; expression) (3 points) Smile factor (2 points) Total: 20 points

Votes for the People's Choice prize will be tallied through the Ginninderry Locals Facebook Page. The Top 10, as determined by the judges, will be uploaded. The photo with the most 'likes' will receive the People's Choice Award.

Prize Details

There are a total of four (4) prizes:

- First prize is one night for two in "Dinny" the tiny house at Cubby and Co, above the Mt Majura Vineyard. www.nakedcubbycollective.com. Value of \$390. Dinny is open from February December.
- Second Prize is a two hour Go Boat voucher (www.goboat.com.au/canberra/) valued at \$199.
- Third Prize is a Café Stepping Stone Sunset Pizza Night Voucher valued at \$100.00. Sunset Pizza Nights operate throughout Summer.
- The People's Choice Award will receive a Voucher to the Strathnairn Arts Association's SHOP valued at \$100.00.

Notification of Winners

The prize winners will be notified via email and Direct Messenger of the Platform (as defined below) on which the entry was submitted. If there is no response from the winner within 5 days via email or Direct Messenger from the notification sent on 21 July 2023, the winner will be messaged again and given a further 48 hours to respond. If there is no response, the winner will forfeit their prize and runner ups will be contacted via email and Direct Messenger of the Platform on which the entry was submitted. This approach will be applied until a winner is determined.

Further Terms

- 1. Entries must be received by Riverview Projects during the Competition Period.
- 2. Entries received after the close of the Competition Period will not be accepted.
- 3. Decisions of Riverview Projects and its panel of judges are final and no correspondence will be entered into regarding the judging of the entries.
- 4. All ancillary costs including but not limited to insurance, taxes, meals, drinks, transport, transfers, spending money, fuel, oil and services costs, safety gear to comply with state and territory regulations, in-room charges and any and all other expenses incurred as a consequence of receiving the prize are the sole responsibility of the winner, unless explicitly stated otherwise.
