

# Macnamara Land Ballot

## Key Dates and Process

### KEY DATES

**27 September 2024** – Registrations open for the Macnamara Land Ballot (click to see [Sales Documents](#)).

**20 October 2024** – Registrations close at 5pm.

**1 November 2024** – The Draw is conducted by Ginninderry, and results of this draw will be emailed to successful registrants by 5pm.

**13 November 2024** – Block Selection Session times are announced at 5pm and will be emailed to successful registrants.

**16 November 2024** – Block Selection Sessions start. This will be conducted by Ginninderry Sales Consultants at The Link - 1 McClymont Way, Strathnairn, ACT, 2615.

### REGISTRATION

To participate in the Ballot, you must complete and submit the Ballot Application Form by **5pm, Sunday 20 October 2024** at <https://ginninderry.com/ballot-registration/>. Please carefully review the details in the [Macnamara Ballot Conditions](#) to ensure your registration is completed correctly. Upon successfully submitting your completed registration form an automatic generated email will be sent to you confirming receipt. This email will provide you with your unique Ballot Registration Code to be used for the draw. If you do not receive this email after submitting registration you will need to contact Ginninderry directly. If upon receipt of your registration Ginninderry determine that there are grounds to reject your application to participate in the sales process in accordance with the [Macnamara Ballot Conditions](#), you will be notified accordingly and subsequently removed from participation in the Draw.

### THE DRAW

Using the unique Ballot Registration Codes, a computer-generated program will be used to randomly assign Draw Numbers to the codes, providing a fair means to place all successful Applicants in priority order for the opportunity to secure a Block from Ginninderry as part of this sales process. Ginninderry will then email you to provide your Draw Number and ask you to confirm your willingness to continue to participate in the sales process and be eligible for a Block Selection Session. You are required to confirm your willingness to proceed before you will be contacted to confirm your Block Selection Session Time.

### BLOCK SELECTION SESSION

All successful pre-qualified Applicants will be allocated a Block Selection Session time in the order in which Ballot Registration Code were drawn. The first drawn Ballot Registration Code will have first priority for the selection at the Block Selection Session.

Selections will continue in order from the first drawn to last drawn Ballot Registration Code as per the Draw Numbers until all Blocks have been sold or there are no more pre-qualified Applicants at the Block Selection Session wishing to purchase a Block.

During the Block Selection Session, you will be allocated 5 minutes to select your Block from those available. Once you have selected your Block you will be required to exchange the First Grant Contract and pay 5% deposit on the Block you have selected.

If you are unable to attend your Block Selection Session in person, you can appoint an agent to attend and select a Block on your behalf. The agent will need to provide a signed [Appointment of Agent Form](#) and proof of identification for themselves and all Applicant/s at the Block Selection Session.

### EXCHANGE AND SETTLEMENT

You will be required to exchange the First Grant Contract at the Block Selection Session. You will also be required to pay 5% deposit specified in the First Grant Contract.

Settlement is when you pay the remainder of the purchase price in return for ownership of the Block. Once you are notified of a settlement date, you will need to arrange to pay the remaining balance of your purchase price at settlement.

## Block Selection Session Checklist

**Date: Saturday, 16 November 2024**

**Place: The Link – 1 McClymont Way, Strathnairn, ACT, 2615**

### IN PREPARATION

Please ensure that you bring the following to your Block Selection Session:

- ✓ All persons whose name/s will be on the First Grant Contract (e.g., your spouse or partner) are required to attend, unless an Agent has been appointed - see Appointment of Agent below;
- ✓ A list of your Block choices in order of preference, once your Draw Number has been called you will have 5 minutes to select a Block.
- ✓ A copy of your Block Selection Session confirmation email;
- ✓ Proof of identification and current address (e.g. driver license or passport and proof of current address such as a utility bill);
- ✓ Solicitor details;
- ✓ Your deposit (being 5% of the Block price) in one of the following forms:
  - Bank or personal cheques made out to "Suburban Land Agency"; or
  - Electronic Funds Transfer (EFT), or
  - EFTPOS. Please confirm with your bank regarding your daily transaction limits and any pre-approvals required to exceed daily limit; or
  - Credit card.
  - Cash will not be accepted.

### APPOINTMENT OF AGENT

If you are unable to attend the Block Selection Session and are using an Agent to select a Block on your behalf, your Agent will need to bring the following additional items to the Block Selection Session:

- ✓ Proof of your identification and current address (a photocopy is acceptable) and proof of identification for the Agent.
- ✓ An original completed [Appointment of Agent Form](#).

On Arrival:

- ✓ You will be required to check in with a Ginninderry representative to confirm that you have arrived for your Block Selection Session. Please arrive at least 30 minutes prior to the commencement of your Block Selection Session to ensure that you are checked in and ready for your Block selection. If you are late to your Block Selection Session or do not select a Block within the allocated timeframe, the Ginninderry Sales Consultant will proceed to the next Applicant, and you will go to the back of the queue for the whole ballot or as otherwise determined in Ginninderry's discretion.
